For example, if a container contains different types of clothing, an additional fee of USD 1,500 will be charged once.</p> <p>For different product categories, if a container contains multiple items subject to surcharge, the fees will be stacked according to their respective HS codes. For example, if it contains both shoes and clothing, the fee will be USD 1,500 * 2, and so forth.</p>
